## TERMS OF USE AGREEMENT

This Terms of Use Agreement (“Agreement”) constitutes a legally binding agreement made between you, whether personally or on behalf of an entity (“user” or “you”) and **Garcia Adjustment Corp** and its affiliated companies (collectively, “**GAC**” or “Company” or “we” or “us” or “our”), concerning your access to and use of the [www.]GarciaAdjustment.com website as well as any other media form, media channel, mobile website or mobile application related or connected thereto (collectively, “**GarciaAdjustment.com**” or the “Website”). **GarciaAdjustment.com** provides the following services: **GAC** Client Engagement Portal, **GAC** Services List, **GAC** Appointment Scheduling, **GAC** Contact Forms and General **GAC** Information (collectively “**GAC Services**”). Supplemental terms and conditions or documents that may be posted on **GarciaAdjustment.com** from time to time, are hereby expressly incorporated into this Agreement by reference.

**GAC** makes no representation that **GarciaAdjustment.com** is appropriate or available in other locations other than where it is operated by **GAC**. The information provided on **GarciaAdjustment.com** is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject **GAC** to any registration requirement within such jurisdiction or country. Accordingly, those persons who choose to access **GarciaAdjustment.com** from other locations do so on their own initiative and are solely responsible for compliance with local laws, if and to the extent local laws are applicable.

## PURCHASES; PAYMENT



**GAC** bills you through an online billing account for purchases of products and/or services. You agree to pay **GAC** all charges at the prices then in effect for the products you or other persons using your billing account may purchase, and you authorize **GAC** to charge your chosen payment provider for any such purchases. You agree to make payment using that selected payment method. If you have ordered a product or service that is subject to recurring charges then you consent to our charging your payment method on a recurring basis, without requiring your prior approval from you for each recurring charge until such time as you cancel the applicable product or service. **GAC** reserves the right to correct any errors or mistakes in pricing that it makes even if it has already requested or received payment. Sales tax will be added to the sales price of purchases as deemed required by **GAC**. **GAC** may change prices at any time. All payments shall be in U.S. dollars.

## REFUND POLICY

All sales are final and no refunds shall be issued.

### *Regarding Your Registration*

The determination of whether a Dispute is subject to arbitration shall be governed by the Federal Arbitration Act and determined by a court rather than an arbitrator. Your arbitration fees and your share of arbitrator compensation shall be governed by the AAA Consumer Rules and, where appropriate, limited by the AAA Consumer Rules. If such costs are determined by the arbitrator to be excessive, **GAC** will pay all arbitration fees and expenses. The arbitration may be conducted in person, through the submission of documents, by phone or online. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by a party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. Except where otherwise required by the applicable AAA rules or applicable law, the arbitration will take place in Broward County, State of Florida. ## **GENERAL INSTRUCTIONS**

### **WHAT IS A TERMS OF USE AGREEMENT?**

A Terms of Use Agreement is a written set of rules and regulations between two parties, the User and the Company, that the User must agree to follow in order to use the Company's website and services.

### **WHEN IS A TERMS OF USE AGREEMENT NEEDED?**

- How does the User agree to accept the Terms of Service

product, including, among other things:

- how purchases, payment, and returns are handled
- ownership and use of content and intellectual property
- how Users must conduct themselves, including any prohibited behavior
- limitations on liability and disclaimers
- the Company's privacy policy

## **WHO NEEDS A TERMS OF USE AGREEMENT?**

Almost every website or application that provides a service or product has a Terms of Use Agreement.

Here are some examples of websites and apps that use a Terms of Use Agreement:

- **E-Commerce Company** - Ebay, Amazon, Target, Gap
- **Social Media Website or Application** - Facebook, Instagram, Twitter, Snapchat

“terms of use”, according to the service or product it provides and its specific needs. The Terms of Use Agreement can be posted on the Company's website either as a browsewrap agreement or a clickwrap agreement.
